

## **SNAK KING SWEEPSTAKES OFFICIAL RULES**

1. **HOW TO ENTER: NO PURCHASE OR INTERNET ACCESS NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The Snak King Vitner's Hot Cheese Twists Sweepstakes (the "Sweepstakes") begins at 12:00 a.m. Pacific Standard Time (PST) October 30, 2017 and ends 11:59 p.m. PST on November 3, 2017 ("entry period.") There is one way to enter. No other method of entry will be accepted.

To enter during the entry period, share the post on the Vitner's Chicago Style Snacks Facebook page with your snack loving friends and like the Vitner's Chicago Style Snacks Facebook page. Entries must be completed by 11:59 p.m. PST on November 3, 2017. Limit one entry per person. Incomplete entries are void. Odds of winning depend upon the number of eligible entries received.
